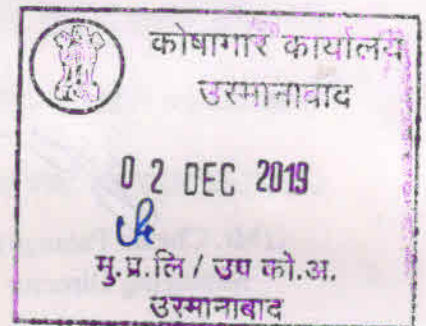

TERMS AND CONDITIONS OF THE AGREEMENT

1. IMPLEMENTATION:

For SE- PES will take complete responsibility for organizing and implementing the knowledge /skill enhancement activity in following manner;

- a) **Training:** One week training program on Spoken and Written English communication
- b) **Industry Expert Session:** Two sessions on "Industry Expectations from Fresh Engineers" and "Industry Accepted latest Technologies" will be organized for SE students

For TE- PES will take complete responsibility for organizing and implementing the knowledge /skill enhancement activity in following manner;

- a) **Training:** One week branch wise technical training program (Php, Android, JAVA, C and CPP, IOT, PLC Scada, CCNA, Ansys, Catia, Solidworks, Primawera, ETab, Stadpro etc as per the choice of students)
- b) **Internship:** 04 weeks as per College/University guidelines to only trained students
- c) **Projects:** As per availability with companies and training conducted

For BE- PES will take complete responsibility for organizing and implementing the knowledge /skill enhancement activity in following manner;

- a) **Training:** Twelve Days branch wise employability enhancement training program (Aptitude + Soft Skills + Resume Writing + Email Writing)
- d) **Placement Assistance:** 03 Companies in campus and other Off Campus and Pool Campus drives as per the availability

2. COURSEWARE:

As per requirement, PES will provide all the relevant study material & certificate for successfully running the Internship/Placement program.

3. TRAINING EQUIPMENT:

The relevant Tools, Equipments and Devices that will be required to conduct the Training and Placement Program shall be provided by COEO and shall remain the property of COEO, while required software will be provided by PES.

4. HUMAN RESOURCES:

PES will provide training personnel that will be required for running the Training and Placement Program

Other Services:

PES will help institute in strengthening institute-industry interaction through following activities;

- Signing of MoU with industries for live projects, industrial visits, expert sessions etc
- Development of incubation centers for latest technologies
- Industrial training for faculties of COEO
- Providing industrial consultancy to COEO staff
- We will try to cooperate to the extend possible in NAAC/NBA accreditation process and during NAAC/NBA peer team visit to the institute

For SE- 1st installment of 50% of the amount needs to be paid in advance before the start of the process, 2nd installment of 50% of the above said amount needs to be paid post completion of Training.

For TE and BE- 1st installment of 40% of the amount needs to be paid in advance before the start of the process, 2nd installment of 40% of the above said amount needs to be paid post completion of Training and the final installment of 20% each needs to be paid upon successful completion of internship/recruitment process respectively.

6. **INSTITUTIONAL REQUIREMENTS:**

For effective implementation of the Programme the COEO will provide the following Institutional resources and facilities to PES.

- a. Lecture room, with benches, black board & Projector, for Theoretical Training and orientation program.
- b. The College authorities will allow PES to give classroom talks/lectures/seminars in each class in the University/colleges.
- c. PES will check the arrangement required for training program before one day.
- d. Lodging/Boarding, and accommodation, Food and travel expenses (not Airfare and provided affordable travelling expenses) of the HR personals of various companies visiting the college for recruitment purposes.
- e. Travel of the trainers will be born by PES and their accommodation(In college guest house) and food (In college canteen) will be born by COEO

7. **CONTRACT AGREEMENT:**


That it is clearly agreed by and between the parties that the duration of the contract /this agreement shall be initially for a period of one (1) year from the date of signing this agreement, and after completion of the said period, the COEO & the PES may extend it for further two years, on the basis of services provided. The COEO hereby agrees that it shall not employ, directly or indirectly, on full time or on part time basis any past or present employee of the PES. Similarly the PES shall also not employ any employee of the COEO. This agreement shall take effect and be construed in accordance with the laws of India and be subject to Jurisdiction of courts of Osmanabad.

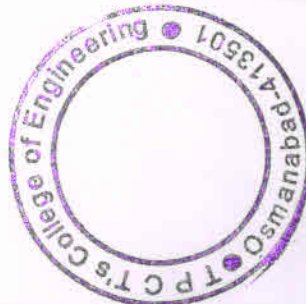

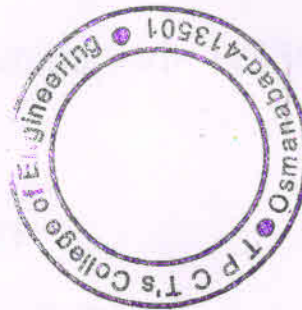
